a. Administrator – Wayne Pallett

- 1. Thanks for supporting Jax Thank you to School Council for initiating support for Jax celebration of life with food and other aspects. A student is working on a portrait for Jax's family. Thank you to parents who contributed. We were able to raise \$1,250 for the family.
 - a. Wellness team have a long-range plan to help with family and friends.
 - b. Parent suggestion to have School Council to remember 3 m, 6m, etc as a check in with family
 - c. Someone from Lethbridge Family Services gave a presentation for parents and staff about some of the resources available for parents and students.
 - d. Morag and Jen Day have been connecting with Wellness team and staff on process and next steps.
- 2. Academic Results January and June Diploma results were shown in comparison with class marks, diploma exams LCI and Diploma Exam Province.

- 3. Gr 9 Academic Matter Grade 9 PAT marks shown. Note: 20-30 students were away by the late date in June when some PATs were run this results in the school receiving a zero for each student.
 - a. Gord Vatcher is doing a presentation to grade 9 students to talk about why marks matter and how it can impact their future stream for classes. US schools take grade 9 marks into consideration. Importance of PAT marks.
 - b. Recommendation for Parent Night for Gr 9 families so they understand what credit counts and academic pathways are available before they choose classes for Gr 10.

- 4. EAL Family Night There has been a big growth in the English as an Additional Language in our community. We have created a new EAL program to help bridge the transition to a new community and school. One challenge has been engaging parents to discuss their students progress. We have partnered with LFS to run parent interviews. There are 32 students in the program at this time. These are students with beginner English. Students that have Intermediate English language. We are hoping LFS will have a few translators available to help.
 - Could an invitation be shared with families that might be willing to help with translation?
- 5. Student Grad committee We have had 3 student grad committee meetings. We meet every Thursday. Last week we had 62 students. We have decided on a black hoodie, we are narrowing it down for the hoodie design. Next they'll determine a theme. We've created a LCI Grad 2024 Teams account where all information will be disseminated through. Saturday, May 25 is the Grad Date.

We are anticipating approximately 290 students graduating.

Parent Questions/Concerns

- Is LCI getting vape detectors for the bathrooms? No, LCI is not on the list for the first pilot due to the size of school and the cost for censors. (Approx \$2,000 per censor) It was an all or nothing pilot. Chinook, Vic Park, Winston Churchill and GS Lakie will be pilot locations.
- 2. Terry Fox Do we do anything at LCI in remembrance?
 - This September's focus was on the 8 days of Indigenous events that LCI held for students. There have been Terry Fox events in the past. The school has to be careful how many events and assemblies they plan for students that take them out of the class as teachers need to stay on track with course timelines.
 - Can a student not participate in Indigenous events if they choose? Answer: yes.
 - Indigenous Bingo nights are being advertised. How is this being funded? Who is invited to these events? At a division level everyone is welcome. The purpose of these events is geared to help Indigenous families feel welcome and have an event that feels more familiar to them. These events help us build relationships with these families, bridge gaps, and welcome families. These events can provide us as staff opportunity to get to know families and have important conversations about their children's school experience and academic progress. There are not a lot of expenses involved in these family nights. The Indigenous Education team runs these events. Their funding comes from Alberta Education.
 - We have run these type of events for other pockets of needs that we identify such as for English as Additional Language (EAL) families or K&E families.

3. Need for LCI Gym moderation.

LCI has an old gym. Our large gym sits on a false floor. If we want to replace the gym floor, which is a need, the under area would need to be filled with concrete. We can not re-sand the floor because it is down to the last sand. To put a new floor in the gym we would need to pour a concrete floor which takes 4 months to cure. This would not address the issue with the size of the gym.

One idea for a fix for the gym would be to have the small gym expanded out into the field. It isn't known if this would be permitted by the government and if the footprint of the school could be expanded.

There are lots of schools that have a lot of needs. Ie. Galbreth recently applied to the city for the expansion of their gym. Other schools need AC, accessible bathrooms, etc.

School Boards are responsible for putting forward a capital plan to the Alberta Government for School Division renos. The province then makes one list out of all the lists submitted based on criteria. A feasibility study has been initiated to look at the westside education needs. LCI will be included in this since LCI has students from the west side.

Three-Year Capital Plan can be viewed on the School Division website.

Concerns: Can't have all students in the gym for an assembly, safety (light falling), floor condition for sports/PE,

There is also an issue with not enough theatre space for productions, band, drama, etc. Supporting in house rather than outside venues.

- Create Society for School Council to Fundraise, or revive old one? Currently we are unable to do fundraising through the School Council. Tiffany made a motion to create an LCI School Society. Table motion until we have more information.
- Follow up from team room discussion Robbin Charlebois We heard clearly that parents are looking for options. We have put together Team Room Opt In or Opt Out Options.
- Teacher Appreciation Luncheon in December (Friday, December 1st) Usually first Friday of December. In the past we've requested monetary donations from parents.

LCI Athletics Volleyball and Basketball Team Room Opt In or Out Options

A LCI volleyball or basketball team will have the following options presented to them at the beginning of the season at the parent meeting. A family will have to vote on the option that works best for the family. Please see the information below regarding parent choice for team rooms. Each choice has an implication on the athletic fee for the activity. After families choose which option works best for them then the athletic fee will be finalized.

Team Room Opt In Option

This option will have the hotel fee that includes team rooms for athletes. The school will book team rooms for student athletes for the season trips. Student athletes can stay with their parents if they choose for various trips, but this will not change the fee for the season. This is our current model for athletics at LCI.

FORM(S): The parent permission form required in this option be the volunteer driver form only. This is to drive students to various tournaments/games.

Team Room Opt Out- Stay with own parent

This option will not include hotels for student athletes. In this option the student athlete stays with their parent(s)/guardian for all trips. The fees for each overnight trip(s) would be removed from player fees in this option. The parent(s) will be responsible to book their own hotel room and is responsible for their players accommodation cost.

FORM(S): The parent permission form required in this option be the volunteer driver form only. This is to drive students to various tournaments/games.

Team Room Opt Out- Stay with another parent

Parents would have to authorize another parent to supervise their child for each trip of the season. This option requires communication between two families at the beginning of the season. No hotel fees would be included in the student(s) athlete fee. The parent(s) will be responsible to book their own hotel room and would be responsible for their player accommodation cost.

FORM(S): The parent permission form required in this option be the volunteer driver form. This is to drive students to various tournaments/games.

A criminal record check would need to be submitted to LCI as parents are acting in a volunteer capacity for overnight supervision. The cost of the criminal record check is the responsibility of the supervising parent.
